

## AAPRCo CONVENTION 2011 – KANSAS CITY, MISSOURI

Cruising by Rail, LTD is participating in a special train from New Orleans, Louisiana to Kansas City, Missouri to attend the annual AAPRCo convention. Our trip will originate in and return to Tucson. Travel between Tucson and New Orleans will be behind regularly scheduled Amtrak trains. From Tucson to New Orleans will be on the Sunset Limited and the Kansas City to Los Angeles portion will be on the Southwest Chief. We will board passengers at any Amtrak station stop. All passengers must be AAPRCo members or a guest of an APPRCO member and will need to be registered for the convention. Only one guest per membership is allowed. The special train will operate on non-Amtrak routes and is expected to travel on non-Amtrak Union Pacific track. In addition to the regular special train we will also have an approximately 2 hour trip over the New Orleans Public Belt Railroad prior to our departure from New Orleans. Layover days in New Orleans and Kansas City will give you the opportunity to visit some of the many tourist attractions near these cities.

Beverage service including beer, house wines, soda and water are included and will be available on all cars. Our return very often runs late, so it is suggested you keep this in mind when booking your flight to your home city. Once we receive your deposit you will be included on the mailing list for all updates and activities.

**INCLUSIONS**

All meals on board while en route to destinations or as contracted.

No refund of trip price if reservation is canceled within thirty (30) days of departure.

**SMOKING**

Smoking will be permitted in the vestibules only. **No smoking is allowed inside the cars.**
